CERTIFICATE OF INSURANCE: SPONSORS & SPECIALTY

DUE FEBRUARY 6, 2026

ALL EXHIBITORS, THEIR APPOINTED EXHIBIT COMPANIES, SUPPLIERS, AND CONTRACTORS MUST SUBMIT A CERTIFICATE OF INSURANCE TO SHOW MANAGEMENT.

The following insurance is required:

- ➔ Commercial General Liability with limits not less than \$2,000,000 per occurrence; \$2,000,000 in aggregate.
- ➔ Commercial Automobile Liability covering owned, non-owned or hired vehicles to be used in and out of the Center, such policy to insure loading or unloading hazards with limits not less than \$500,000 in respect of injuries to any one person in any one occurrence and \$1,000,000 in respect of injuries to more than one person in any occurrence and \$500,000 in respect of damage to property, or \$1,000,000 combined single limit.
- ➔ General Liability and Automobile Liability shall include waiver of subrogation endorsement.
- ➔ Umbrella Liability with limit of not less than \$2,000,000.
- ➔ Workers Compensation, statutory benefits including Employer Liability limit not less than \$1,000,000 per occurrence.
- ➔ Name as Additional Insured: *New York Convention Center Operating Corporation, State of New York, the New York Convention Center Development Corporation, the New York State Urban Development Corporation dba Empire State Development, the Triborough Bridge and Tunnel Authority, the Greater New York Automobile Dealers Association, Inc., and their respective boards of directors, officers, agents, and employees. Insurance carriers shall have no right to subrogation against any Additional Insured(s).*
- ➔ Additional Insureds to receive 10-day notice of cancellation or material change.
- ➔ All insurance policies shall be Primary & Non-Contributory.
- ➔ All Insurance companies must have an A.M. Best rating of "A" or better.

Certificate must be inclusive of the following dates:

Crystal Palace: March 25 – April 13, 2026

Level 1: March 25 - April 14, 2026

North Concourse: March 25 – April 13, 2026

Level 3: March 25 - April 15, 2026

Exhibitor(s) WILL NOT be allowed to set-up until a valid Certificate of Insurance is provided. Certificate should be submitted on or before February 6, 2026.
